



**ACKNOWLEDGEMENT OF RISK AND RELEASE OF LIABILITY**  
**(FOR PARTICIPANTS UNDER THE AGE OF 18)**



**WARNING: THIS AGREEMENT WILL AFFECT YOUR LEGAL RIGHTS, READ IT CAREFULLY!**  
Every person must read and understand this waiver before participating in bubble soccer events

Canada Party Crew hereinafter referred to as “CPC” and Bubble Soccer Toronto hereinafter referred to as “BSTO” are committed to conducting BUBBLE SOCCER GAMES in a safe manner and holds the safety of participants in high regard. CPC and BSTO continually strive to reduce such risks and insist that all participants follow safety rules and instructions that are designed to protect the participants’ safety and are provided to them through the host and also explained by our representative before the start of the game, where possible. However, participants and parents/guardians of minors, registering for the Bubble Soccer Event, hereinafter referred to as “EVENT” must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs of this nature. It is always advisable, especially if the participant is pregnant or disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

In full or partial consideration for allowing me to participate in all related events and activities of the Event, I, in my own capacity and as a parent/guardian of my minor child/ward hereby warrant and agree that:

I am solely responsible for determining if I or my minor child/ward is physically fit and/or skilled for playing Bubble Soccer contemplated by this agreement.

- ✓ I agree that I am 18 years old I have reviewed this waiver and consented to its terms, waiver & release of all claims & assumption of risk. I recognize and acknowledge that there are certain risks of physical injury to participants in the Bubble Soccer game, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participation in these activities against the provider as well as the host of the game, including its officials, agents, volunteers, sponsors and employees; and
- ✓ I am familiar with and accept that there is a risk of serious injury and even death in participation, whether as a competitor, student, official or worker, in all forms of bubble soccer sport and in particular in being allowed to enter, for any reason, any restricted area; and
- ✓ I have satisfied myself and believe that I or my minor child/ward are physically, emotionally and mentally able to participate in this EVENT, and that my protective clothing, gear and equipment is fit and appropriate for my role as a participant in this EVENT; and
- ✓ I understand that all applicable rules for participation must be followed, regardless of my role, and that at all times during the EVENT the sole responsibility for personal safety of my minor child/ward remains with me; and
- ✓ I will ensure that I or my minor child/ward will immediately remove themselves from participation, and notify the nearest official, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that I have experienced any deterioration in my physical, emotional or mental fitness, or that of my protective clothing, gear or equipment, for continued safe participation in the EVENT ; and
- ✓ I do hereby fully release and forever discharge CPC or BSTO from any and all claims for injuries, illnesses, damages, expenses, or loss that I or my minor child/ward may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with the bubble soccer game or the or activities associated with the game. Furthermore I fully release and forever discharge BSTO or CPC or any person(s), entities or organization(s) associated in any way with the EVENT including the venue owners and lessees regarding the EVENT or any one or more of them and their respective directors, officers, employees, guides, contractors, agents and representatives (all of whom are collectively referred to as “the Releases”) from any and all liability for any loss, damage, injury or expense that I may suffer as a result of my use of or my presence at the event facilities or my participation in any part of, or my presence in any capacity at, the EVENT, due to any cause whatsoever, including negligence, gross negligence, breach of contract or breach of any statutory or other duty of care owed under the relevant liability act(s) on the part of the releases ; and
- ✓ I acknowledge that by signing this agreement I agree to indemnify and to SAVE and HOLD HARMLESS the RELEASES, and each of them, from any litigation expense, legal fees, liability, damage, award or cost, of any form or type whatsoever, they may incur due to any claim made against them or any one of them by me or on my behalf, or that of my estate, whether the claim is based on the negligence or the gross negligence of the Releases or otherwise as stated above.
- ✓ I do hereby consent to CPC or BSTO for taking photos and video footage (the “FOOTAGE”) of my participation in this activity and may use the Footage for promotional and other purposes in all media and formats worldwide in perpetuity in accordance with CPC or BSTO privacy policies. The latter own the Footage and if requested to do so CPC or BSTO are not obliged to release or provide the Footage. I assign CPC or BSTO the entire copyright and other intellectual property rights subsisting in the Footage in all media worldwide in perpetuity and agree that Canada Party Crew (CPC) or Bubble Soccer Toronto Limited (BSTO) shall have the unfettered right to deal with the Footage in any way it sees fit. I understand CPC or BSTO decision as to the results of this activity is final and not subject to appeal by any participant.
- ✓ CPC or BSTO reserve the right to verify the eligibility of any participant and to disallow participation in the activity if, in the opinion of CPC or BSTO, I or my minor child/ward have breached any of the terms of this agreement or have otherwise acted improperly

I assume all risks and hazards incidental to such participation in the Event, and I hereby waive, release, absolve, indemnify, and agree to hold harmless Bubble Soccer Toronto or Canada Party Crew, its officers, heirs, assigns, administrators, personal representatives and executors, firms, corporations, business, and governments, and all sponsors, their representatives and successors and other persons, for any claim arising or of an injury to my/our child and from any and all claims, causes of actions, obligations, lawsuits, charges, complaints, contracts, controversies, covenants, agreements, promises, damages, costs, expenses, responsibilities, of whatsoever kind, nature or description, where, direct or indirect, in law or in equity, in contract or in tort, or otherwise, whether known or unknown, from all claims or liabilities of any kind arising out of or connected with my child(ren)'s participation in this event. I consent to the foregoing and grant my permission for him/her to participate in the Bubble Soccer Game.

I have carefully read, accepted and agreed to the terms on this Release and Liability waiver, and know and understand their contents as described in the page 1 of this agreement and I sign the same on my own free act and deed.
